

## GB Legal & Compliance General Terms and Conditions as of June 7, 2019

1. These general terms and conditions apply to all services that GB Legal & Compliance has been requested to provide (*opdrachten*). The relevant service agreement under the trade name of *GB Legal & Compliance* is entered into by the founder and owner of this sole proprietorship, Gerbrand W. van Bokhorst.
2. If an event occurs in providing services that could lead to any liability on GB Legal & Compliance's part, that liability will be limited to the amount that is paid out in that specific case under GB Legal & Compliance's professional indemnity insurance, increased by the applicable deductible (*eigen risico*).
3. If GB Legal & Compliance is liable for damage to persons or property, that liability will be limited to the amount paid out in that specific case under GB Legal & Compliance's commercial general liability insurance (AVB), increased by the applicable deductible (*eigen risico*).
4. If for any reason none of these insurance policies entitle GB Legal & Compliance to any payment, GB Legal & Compliance's liability will be limited to a maximum of EUR 1,000,000.
5. Claims for compensation of damage will expire one year after the date on which the client became aware of the damage and GB Legal & Compliance's liability.
6. If GB Legal & Compliance involves a person not associated with GB Legal & Compliance in connection with its services for a client, GB Legal & Compliance will not be liable to the client for any error or omission (*fout*) made by that person. By requesting GB Legal & Compliance to provide services, the client gives GB Legal & Compliance authority to accept a limitation of liability stipulated by that person on behalf of the client.
7. These general terms and conditions may be relied on by GB Legal & Compliance and by any persons associated or formerly associated with GB Legal & Compliance and their legal successors.
8. Pursuant to applicable legislation - including the Dutch Act on the Prevention of Money Laundering and Terrorist Financing - GB Legal & Compliance is obliged to verify the identity of its clients and report unusual transactions to the authorities in certain circumstances
9. Dutch law governs the legal relationship(s) between GB Legal & Compliance and its clients. Any disputes between GB Legal & Compliance and a client will be exclusively resolved in the first instance by the District Court of Haarlem, the Netherlands.
10. The GB Legal & Compliance Complaints Procedure applies to all services provided by GB Legal & Compliance's attorney(s) (*advoc(a)at(en)*).
